Patna Municipal Corporation invites Quotations for following work:

**Sub: Selection of agency for the Establishment of E -Waste Supply chain Management (Awareness, Collection & Recycling of Electronic (E)- Waste) in 3 Zones (Kankarbagh, Patna City & Azimabad) of Patna Municipal Corporation**

#### Introduction

Patna Municipal Corporation (PMC) has incorporated e-waste management as part of its broader solid waste management system, ensuring safe handling, collection, and disposal of electronic waste across the city. PMC's waste management objectives include ensuring safe disposal of special category wastes such as e-waste, alongside other municipal waste streams.

To strengthen its e-waste supply chain, PMC launched an E-Waste Collection & Disposal Scheme, under which discarded electronics from households, offices, and institutions are collected through an *authorized agency* and transported for *scientific recycling*.

The scheme offers citizens for handing over electronic waste, helping increase formal collection and reducing improper dumping. The collected e-waste is then channelled into a controlled recycling process where toxic components (like lead, mercury, and cadmium) are handled safely, and valuable materials are recovered.

Through these initiatives, PMC aims to:

- promote public participation in responsible e-waste disposal,
- formalize the e-waste collection and recycling supply chain,
- prevent environmental pollution, and
- integrate e-waste management into the city's overall solid waste systems.

**Eligibility:**

- (i) The Bidder must be a registered corporate in India under the Companies Act, 1956 or Companies Act, 2013. The documents for the incorporation as a Company should be submitted.
- (ii) The Bidder must be registered with Central Pollution Control Board (CPCB) under the category of E-waste Recycler. The copy of certificate in this regard must be submitted. Page 3 of 14 Empanelment of e-waste recyclers for e-waste disposal iii.
- (iii) The Bidder shall not be under a Declaration of Ineligibility for corrupt or fraudulent practices or debarred / banned / blacklisted with any Government Agency. A Self Declaration to that effect should be submitted. iv.
- (iv) The Bidder should have executed the e-waste recycling for at least two organizations (Government / PSU / Higher Education Institution / Research Institution) in the national region, in the three years preceding the bid submission date
- (v) The Bidder should have a full-fledged office & Collection centre in Patna and should have arrangements to provide e-waste recycling services in Patna.

Bidder needs to provide supporting documents against each eligibility criteria.

**Scope of work: -**

- a) Awareness / Sensitization workshop among stakeholder (All Government Department, Institution, Colleges) & establish E Waste Collection Centre
- b) Meeting with Brand owner & establish collection centre in collaboration with Bihar State Pollution control board in PMC Region (Kankarbagh, Patna City & Azimabad)
- c) Conduct e-waste awareness activities in the city of Patna (Kankarbagh, Patna City & Azimabad)
- d) Promote responsible e-waste disposal among citizens, institutions, and commercial establishments.
- e) Ensure periodic collection drives across Patna (Kankarbagh, Patna City & Azimabad)
- f) Ensure collected e-waste is formally recycled in compliance with the E-Waste Management Rules.


